The II Semester, 2014-15 examination results of B.Sc. (Ag.) & B.Sc. (Hort.) and B.Tech. (Agril.Engg.) programme may not be notified on or before the date of I Semester 2015-16 registration i.e. 23/07/2015. Therefore, as per the kind approval of Hon'ble Vice Chancellor, admission in I Semester 2015-16 (to II, III and IV year students) may be given provisionally after taking an undertaking by each student. Accordingly the attendance will also be counted. Under such circumstances, there may be following types of cases:

1. Students who are failed in 6 or less than 6 subjects – Can be permitted for provisional admission and registration in next higher class.
2. Students who are failed in more than 6 subjects – Should not be permitted for admission and registration in next higher class.
3. After declaration of results of II Semester 2014-15, some students may fall under the category of 1. or 2. Those students may be considered for admission and registration accordingly.

The date of I Semester 2015-16 registration will remain 23/07/2015. The proforma of undertaking is enclosed herewith.

NOTIFICATION

The Academic Council in its 100th Meeting held on 16th March 2015 approved the amendments in UG, PG and Ph.D. Academic Regulations in reference to fee deposition and registration by continuing students. The modified version of fee deposition through online will be as follows. This will be effective from academic session 2015-16 :-

Online fee can be deposited with late fee of Rs. 100 per day from 06 day to 13 day (including holidays).	<ul style="list-style-type: none"> • Date of registration 23-07-2015 (No late fee upto 27-07-2015) • Late fee from 06 day upto 13 day (04-08-2015) is allowed. • If fee deposited on 28-07-2015 Rs. 100 late fee will be required in addition to normal fee. • If fee deposited on 30-07-2015 Rs. 300 late fee will be required in addition to normal fee.

However, for all the students who have taken admission through manual counseling (old), existing academic regulations (for UG 4.0, for PG 4.0 and for Ph.D. 4.0) will remain effective. It means that for online fee deposition total 13 days (including holidays) will be permitted with late fee, whereas, for other cases (Payment of Fee and registration in person) existing Academic Regulations will be applicable for continuing students.
